PROPOSED AMENDMENTS TO BYLAWS OF LOCAL LODGE 2508

***** NOTE: Article VIII, Amendments, of Local Lodge 2508 Bylaws as shown below, describes the procedure for proposed amendments to the Bylaws of this Lodge. Please read this entire notice carefully and be sure to follow all requirements in submitting a proposed amendment. *****

ARTICLE VIII

AMENDMENTS

Section 1. (a) During the month of **March** and prior to **April 1** of each year, the membership will be advised by the Recording Secretary by bulletin board of the possibility of amendments, changes, additions and/or deletions to these bylaws.

(b) All proposals must be in writing **on a form provided by the Lodge**, signed by not less than five (5) members, and referred to a Bylaws Committee appointed by the President.

(c) Must be read as proposed at two (2) consecutive meetings. Immediately following the second reading, the Bylaws Committee shall submit their recommendations.

(d) Reasonable advance notice must be given to the membership of the time, date, and place of the second reading, and vote to be taken on the Bylaws Committee's recommendations.

(e) Each proposal must be considered and voted upon separately. A majority affirmative vote by those present and voting is needed for adoption.

Local Lodge 2508 provides forms to be used to submit any proposed bylaw changes on. These forms are available through your Grievance Committee beginning the last week of February. You may also obtain a form by contacting a member of the Bylaws Committee.

ALL SECTIONS OF THE FORM MUST BE FILLED IN.

Proposed Bylaw Amendments may be submitted beginning March 1, 2010.
**The Deadline for acceptance is 12:00 p.m. (noon) on
Wednesday, MARCH 31, 2010.**

You may submit these amendments to your Grievance Committee so that they may route them to the Bylaws Committee. Or, you may submit them directly to a member of the Bylaws Committee. If you wish, you may mail them to the Bylaws Committee in care of:

WEDNESDAY, MARCH 31, 2010.
